The Super CDW does not cover Lost Car Keys, Fuel contamination (petrol into diesel engine), Tire damage, Wheel Damage and Glass Damage.

You may now add Tire, Wheel & Glass Coverage to your rental contract from €7.00 euros per day. You can do that at the Hertz counter.

Note: Tire & Wheel Coverage (CP) does NOT cover the cost of fixing a flat tire. Hertz vehicles come with either a spare tire and jack and/or a compressed puncture repair system that will seal the puncture from the inside of the tire and allow you to proceed to the nearest garage to get the tire repaired. If you accept the optional CP - Wheel & Tyre (tire) Cover (CP), in addition to **SC** (**Super Cover** included in Fully Inclusive Rate), your financial responsibility for accidental damage or loss to the vehicles wheels and tyres will be reduced to zero. CP does not cover fuel contamination and/or damage/loss of keys. Also should you have to replace a tyre (tire) during your rental bring the receipt for the purchase to the Hertz agent when you return the car and that amount will be credited to your rental.

Hertz assistance while driving your rental car: A BASIC break down service is included in the Customer's rental to cover Call Outs for mechanical faults and Accident. PREMIUM EMERGENCY ROADSIDE SERVICE (PERS) will be available to purchase at the Hertz counter starting at €5 Euros a day. You can purchase this additional coverage for the Call Out Costs relating to breakdowns that are the driver's fault with the PREMIUM ROADSIDE SERVICE AGREEMENT INCLUDING Flat Batteries, Flat Tires, Keys locked in vehicle, Towing as the result of a Lost Key (excludes the cost of replacement of the key), Running out of fuel. Customer will only need to pay for additional items needed to get back mobile such as replacement fuel, Tires, Keys, etc.

A Rental Day: Car rental rates are calculated in 24 hour increments so if you pick up at 10:00A on Day 1 and return at or before 10:00A on your return day the rate stays the same. Should you return the car after your pick up time on the return day your rate would increase by one day.

Special Note: Maximum Driver Age: The Conn's Ireland Car Rental Fully Inclusive Rate with Hertz Ireland has an upward age limit of 79. From 76 through 79 Hertz requires a letter from your doctor stating you are in good health to drive. Also a letter from your auto insurance agent stating you are actively driving, hold an auto insurance policy and have had no accidents in the last five years. Once you reach 80 the Fully Inclusive Rate is not available.

OPTIONAL Hertz Never-Lost GPS Rental: You may add Optional Hertz NeverLost GPS to the rental for: € 11.35 euros (including tax) per day, € 68.10 euro (including tax) per week, and € 272.40 euros (including tax) per month. Portable Hertz NeverLost device is not covered by CDW, TP, PI, Super Cover or any othercoverage in the event of loss damage or accident.

If you wish to add a second driver to the liability insurance the cost is €10 (euros) a day.

Car seats are available at €40.00 for the rental period and €14.99 for the Booster Seat.

CROSS BORDER FEE TO DRIVE INTO NORTHERN IRELAND

Northern Ireland is part of the United Kingdom and the UK is no longer a European Union member country. The Republic of Ireland IS a member country of the European Union. When picking up the car you must now advise the Hertz agent at the counter that you intend to drive into and through Northern Ireland. There will be a cross-border fee of approximately €30 euros. Permission to drive in Northern Ireland MUST be stamped on your Rental Agreement.

A note regarding luggage capacity: A large suitcase would be 26" or 29" and a small suitcase would be 19" or 22." Be sure you have chosen a vehicle that will meet the passenger comfort and luggage capacity for the number of passengers you have.

EXTRA! EXTRA! - I WISH TO ADD SOME ADDITIONAL COMMENTS REGARDING LUGGAGE CAPACITY. When I provide the definitions of a large suticase and a small suitcase i should have cautioned that that applies to NOT using the Expansion zipper! If you overfill a suitcase or use the expansion zipper then you are DOUBLING the girth of the suitcase so now it becomes TWO suitcases instead of one.

Please note - When you arrive at the Hertz counter you will present your driver's license and the credit card you wish to have charged for the rental. You will be asked if you wish to purchase the optional Tire & Wheel Coverage (see above). As your rental car will be delivered with a full tank of fuel you will also be asked if you wish to purchase the fuel in the tank (Fuel Purchase Option - FPO) at a discounted price per liter. If you decline that you will need to return the car with a full tank to avoid a refueling charge at a higher price per liter.

Please note - You can request a choice of currency to pay for your rental charges; whether to charge your card in USD or Euros. This decision HAS TO BE MADE at the time of pick-up. That decision will be FINAL and cannot be changed when you turn in the car. Make sure you advise the Hertz CSR at the counter that you wish to elect this option.

Please note - The Hertz CSR (Customer Service Representative) will obtain an authorization on your credit card for the confirmed amount of the rental (including any extras you added at the counter such as additional driver, Tire & Wheel Coverage, Wi-Fi Hotspot rental, Hertz NeverLost GPS rental) and the value of the fuel in the tank. When you return the car at the end of the rental your credit card will be charged using the preauthorization obtained at the beginning of the rental.

Please note - A service charge of € 5.68 (including tax) will be applicable on all payments made with non-EU issued credit/debit/charge cards.

You won't have any surprises!

GO TO THE HERTZ COUNTER OR HERTZ LOCATION ON YOUR CONFIRMATION

You will be receiving your rental car from Hertz in Ireland.

The rental is guaranteed by a credit card but the credit card is not charged until the end of the rental.

Once confirmed the price is GUARANTEED in euros and YOU don't pay for the rental until then turn in the vehicle.

You can book the vehicle online at <u>connsirelandcarental.com</u>. In order to complete the reservation you will need a credit card number to hold the reservation when it is made. - Fintan can meet you as you exit Customs at Dublin Airport and take you to Hertz and go over all the instrumentation and then pilot you to the road out of Dublin.
- If you are staying in Dublin he can transfer you to your hotel.
- After your stay in Dublin on your car rental first day he can meet you at your hotel, transfer you to the Hertz location, then pilot you out of Dublin to the road you need to be on.
